EXECUTIVE DIRECTOR'S REPORT:

2012 FUND YEAR BUDGET - AMENDMENT: Last month the fund introduced an amendment to the 2012 budget to include the addition of Salem County (effective 10/15/12) and Cumberland County Insurance Commissions (effective 10/4/12). Enclosed in the agenda was a copy of the amended 2012 Budget for review and discussion.

2013 FUND YEAR BUDGET: Enclosed in the agenda was the 2013 Budget which reflects a few changes from the budget introduced on 11/9/2012. Executive Director said the budget now reflects changes in the underlying Commission exposures in Burlington, Salem and Cumberland amounting to an increase of \$26,850. In addition, the budget reflected a shift of \$313,021 in excess property premium (line 7) to a new excess premium contingency (line 9). Executive Director said the explanation for this contingency is outlined in the Underwriting Manager's report concerning possible changes in the casualty excess program.

Executive Director said Hurricane Sandy left a lot of uncertainty on the impact it would have on the property market. Executive Director said as discussed at previous meetings, Meadowbrook indicated they may leave the program in 2013. Executive Director said the agenda included a casualty re-marketing report by the Underwriting Manager. Underwriting Manager reviewed his report and said the change in the budget contingency was a result of possible carrier changes in the casualty excess program. Underwriting Manager said he has been aggressively marketing the NJCE JIF program to other carriers to replace Meadowbrook.
