PROFESSIONAL SERVICES: TPA SERVICES: At the June 27th JIF meeting, Fund Attorney reported that there was a pending agreement between AmeriHealth and Claims Resolution Corporation (CRC) to purchase the TPA business offered through AmeriHealth Casualty Services. No official action was taken, and the next steps were to set up a meeting with relevant parties to discuss the pending agreement.

Executive Director reported that on July 23rd, the NJCE Fund Chair & Secretary, Fund Attorney, Fund Treasurer, Executive Director and select professionals met with representatives from AmeriHealth and CRC to discuss transition, staffing plan, data migration and transfer of service. Fund Attorney provided an overview of the discussion noting a productive meeting and confidence in Claims Resolution Corporations ability to pick up where AmeriHealth left off. Fund Attorney recommended the authorization of assignment of contract from AmeriHealth's TPA services to CRC via Resolution 28-24. Following authorization of assignment, the letter of consent will be executed and returned to AmeriHealth.
